Newspaper Publisher
 Lithopass has submitted three proposals for publishing of the Core Courier, they are:

- a) Compile and print the publication and SCCA covers the full cost of \$8,000 per month. Possibility of SCCA selling ads and collecting the revenue directly to offset costs.
- b) Split the cost with SCCA and advertisers to keep the prices lower for potential advertisers. 1<sup>st</sup> 3 months would be \$5,000 per month and thereafter \$4,000 per month. This assumes advertisers will get on board with company.
- c) They sell the ads and collect revenue from them to cover the cost of the publication. This would require 3 months to get current advertisers to sign up with them. If we cannot wait 3 months then they ask that we cover postage and printing costs while goal is reached. After 3 months if the cost of publishing is not covered by ads they would negotiate the cost with us.
